\$25K Titled Land Offer | Terms and Conditions

- 1. In these terms and conditions and all advertising material relating to the "\$25K Titled Land Offer" promotion (**Promotion**), **Villawood** means Villawood Management Pty Ltd unless the context indicates a contrary intention.
- 2. The Promotion commences at 9:00am (AEST) on 1 August 2023 and ends at 5:00pm (AEST) on 30 November 2023 or such later date notified by Villawood by providing at least fourteen days' notice on <u>www.villawoodproperties.com</u> unless sold out prior (**Promotion Period**).
- 3.
