

# Imagine \$15,000 Cash Back Promotion

## Terms and Conditions

- 1 In these terms and conditions, as well as all advertising material related to the 'Imagine \$15,000 Cashback' promotion (Promotion), 'Villawood' refers to Villawood Management Bendigo Pty Ltd.
- 2 The Promotion runs from 9:00 am (AEST) on 10 January 2025 to 5:00 pm (AEST) on 21 February 2025, unless extended by Villawood with at least 14 days' notice provided on [www.villawoodproperties.com](http://www.villawoodproperties.com) (**Promotion Period**).
- 3 The Promotion applies exclusively to specific residential lots within the Villawood residential estate known as Imagine, (but, for the avoidance of doubt, the Promotion does not apply to residential lots within the Alamora, Armstrong, Aspire, Coridale, Delaray, Drew's Paddock, Estuary, Frawleys Paddock, Kimberley, Maidens Green, Rathdowne, Redstone, Rhondda Park, Sherwood Grange, and Williams Walk estates in Victoria, and the residential developments in South Australia and Queensland).

- 5 Subject to paragraphs 6, 8 and 9, the persons (each a Purchaser) who enter into an unconditional contract of sale of real estate in the standard form used by the land owner (Contract of Sale) during the Promotion Period will receive a once-only cash payment of \$15,000. This payment will be made to a nominated bank account as specified by the Purchaser(s) upon the successful completion of the land settlement. The total cashback amount available for each Lot is \$15,000, regardless of the number of individuals entering into the Contract of Sale.
- 6 To be eligible for the Promotion as outlined in paragraph 5, the Purchaser, along with any spouse or partner of the Purchaser, must not have previously claimed a rebate under the Promotion.
- 7 The Promotion is not available in conjunction with any other Villawood promotion or offer.

- 9 Villawood reserves the right to withdraw any individual lots from the Promotion at any time.
