Rathdowne Garden Grow Off Competition Terms & Conditions

The Rathdowne front garden competition (Competition) is subject to the following terms and conditions:

- 1. The Entrant is the person that has completed the Registration Form.
- 2. By entering into the Competition, the Entrant gives their consent to providing their personal information to the Villawood Properties Pty Ltd (Promoter) in accordance with the Personal Information Collection Statement.
