As a consequence of the limited depth of fill materials, field density testing was not considered warranted. However, when classifying the site in accordance with the procedures presented in Section 2 of AS 2870 – Residential Slabs and Footings – Construction (2011), we are of the view that the bulk fill materials that were placed on this Lot by Winslow Constructors Pty Ltd can be considered as being placed in a controlled manner to a minimum density ratio of 95% (standard compactive effort).

LIMITATIONS

The use of this Certificate is only appropriate for the field conditions present up to 21st March 2014.
